

District IX Business Meeting

June 9, 1980

Sheraton Inn, Philadelphia, PA

Meeting was called to order by Bobby Barton at 4:30 p.m.

- I. Anyone interested in serving as District Secretary should see a member of the Executive Committee, which will meet to further consider the matter. The Executive Committee agreed with the membership that District 9 cannot continue to function without a secretary at all national and district meetings, regardless of the reasons for his previous absences.
- II. The Board of Directors voted that all certification hours must be accumulated after the person has joined the NATA. This is not retroactive. The vote was 5-5 on the issue, President Chambers deciding in favor of the proposal Dr. Barton voted against. This will be effective this fall, so all students are urged to join the NATA. There is a form recommended for use in documentation of hours.
- III. The Journal Committee is now headed by Ken Wolfe. He outlined several Journal changes, and recommended referral to the guidelines for contributors before submitting material. Case studies, tips from the field are especially encouraged.
- IV. Dues for student membership have been raised to \$25.00 plus district dues.
- V. The board has passed a resolution recommending ground fault circuit breakers be used in all hydrotherapy equipment.
- VI. Certification Committee is undergoing several changes at this time and may continue to do so. Al Green (UK) has been nominated by Bobby Barton for the position of Certification Chairman.
- VII. With regard to COPA, there seems to be a trend in most health fields to have some kind of accreditation. COPA is closely aligned with licensure. It was reported that licensure seems to be a dead issue in most states. Certification or registration seems to be a more promising route. There is also concern about NATA curriculums teaching the use of electrical modalities. Unquestionably, this could be legally challenged.
- VIII. Licensure
  - Louisiana: Bill has been introduced and has gone to committee. The PT's have introduced an amendment to their bill which would forbid anyone but a PT from administering physical therapy.
  - Florida: The situation is not receptive to licensure. Until a good case can be made, legislators individually are advising against it at this time.
  - Tennessee: In Legislature.
  - Mississippi: Representatives of trainers and PT's meet this summer before presenting the issue to the legislature.
