July 8, 1977

1. Summary of Dearborn business - Barton  
Fred Hoover spoke on reasons why we should not use competitive hotels for convention.
2. Bobby Barton must decide within one year whether he will step down in two years or stay as director for 5 years.
3. Application fee must be raised due to postage hike.  
 Student applications must be re-routed thru District Secretary's office.
4. Steve Moore
  - . Financial outlook for District 9 is good.
  - . Wants to keep meeting in Atlanta--must consider exhibitors.
  - . Membership report
    - Need to increase all dues by \$2--\$12 instead of \$10.
  - . Newsletters and mailing - \$1,032.31--mainly postage.
  - . If mailing is returned, name is taken off district and national lists..
  - 103 certified - 58 associate - 121 student - 2 affiliate - 15 advisory
  - . Minutes of Dearborn meeting will be mailed out.
5. Olympic Committee will select 6 full-time athletic trainers for training sites.  
 Bill Chambers is writing NATA statement of opinion on selection of trainers.
6. Do we want to change site of District 9 meeting? must state specific site--found not possible.  
 Motion made by Leroy Mullins to come back to Atlanta next year, weekend following 4th of July, and if someone finds an alternate site, bring all arrangements and plans to Atlanta in 1978; motion seconded by Roy Don Wilson; motion passed.  
 Steve Moore is to make arrangements with Atlanta for next year.
7. Convention Chairman for District 9? District 6 format discussed.  
 Motion, John Lopez--Appoint a chairman to head up district meeting on yearly basis to be elected periodically and his members to be appointed on annual basis.  
 Seconded, Terry Lewis.  
  
 Admended by John Lopez? Assistant Director of District 9 is Chairman of Committee and appropriate members would be selected for committee on an annual basis; seconded by Terry Lewis; amended motion passed.
8. Raise dues by \$2?  
 Discussion--Tom Simmons: "I move that we raise the dues \$2." Seconded; Failed 15-30.
9. Districts having severe internal problems...
  - due to lack of communication between director and members.
  - Barton will vote the way district votes.  
 Proposal--all items are sent out before Board of Directors meet. Not feasible to talk to everyone before meeting.
